#### **Presidents Report**

#### Overview

Firstly, Bowls ACT and the sport we play cannot be successful without the hard work of our member clubs, committees, members, all administrators, players, and volunteers thank you for your contributions and ongoing support to Bowls ACT over the past year. The past 12 months have seen some challenges, some disappointments but ultimately a lot of positives around growth and participation.

The Bowls ACT Board has seen reasonable stability with no changes for the most part of 23-24 with only the recent resignation of Will Penny the only change to the board from the last AGM. We thank Will for the work he did and know he will continue to stay an active participant in the bowls community. Our Executive Officer Nick Hind has now had over a year in the role and has found his feet and is delivering on numerous fronts. We thank Nick for his continued efforts and innovative thinking he is providing to the role. There are still many challenges ahead to work through, but I know between Nick and the board we will continue to meet and complete all the challenges as they present themselves.

The stability on the board has seen more accomplished as the board members have a specific focus on the portfolio directives. We have seen an increase in junior participation, with great success at junior carnivals and come and try days. I would like to thank Yass Bowling Club and Yowani who have been the leaders, providing great support to BACT with junior programs. There has been a lot of work done behind the scenes improving processes for Event management including the continued use and development of BowlsLink and I thank all who have taken the time to educate themselves and others on the use. Our digital presence is ever increasing and showing great response and interaction levels, highlighted by the data received from the completion of our first BACT live streamed event at the 2023 Greenline Invitation Singles. BACT are committed to continue to grow and develop streaming opportunities and aid clubs into the future with support and capability to provide streaming as well.

The 2023 Representative schedule was again successful with the Nationals being hosted in Perth. Bowls ACT continued to build on its competitiveness and success against the bigger states from 2022 with multiple medals won again in Australian Championships along with the successful retention of the Territory Shields and massive wins against Victoria, Tasmania and Queensland across the open and senior sides respectively. It should also be noted that 2023 saw ACT represented in both Junior Boys and Girls at Nationals with excellent results by all participants. It was also great to see ACT Players recognized further with selection into Bowls Australia Representative Programs. James Reynolds into the Para-Jackaroos squad which is also resulted in World Championship Gold Medal along with Chloe Morrison (Emerging Jackaroos) and Flynn O'Shaughnessy (Pathway Jackaroos) retaining their spots now being joined by Harvey McAlister in the Pathways program.

The biggest challenge for the year was obviously the closure of the bowling facilities at Yowani. This was a shock to the members and a disappointment to Bowls ACT and the sport in general. I would like to commend the Yowani members on how they conducted themselves and the processes they put in place to aid and support members in finding new homes at other clubs. I would also like to thank all clubs that have welcomed and provide a successful transition for Yowani members. While the closure was a great disappointment we have seen growth in the Weekend Pennant competition with team entries across the grades increased. Alongside the continued growth in participation in State Championships our sport is in a great position to capitalise.

#### Strategic Highlights

Bowls ACT secured a new commercial partner with Greenline coming on board for 3 years as the naming rights partner to the Invitational singles which secures the immediate future of the event and will allow opportunities to continue to build on this marquee event for the Capital region.

2023-24 saw the introduction of a Graded Reserve Championship to be played concurrently with the State Championships. BACT has seen this event as a very positive step forward and believe it has aligns with the 2022-2025 Strategic Plan and provides a more opportunities for more people to play more bowls.

With the Executive Officer securing approval to use ACT Government Grant funding the recent addition of an operations assistant to Bowls ACT ranks has allowed the Executive officer to focus on needed governance improvements and achieving deliverables against actions in our strategic plan.

#### **Operating Highlights**

BACT continues to focus on providing a better level of communication and provide greater transparency of the operations and events across the ACT. Bowls ACT in 2023 began conducting members forums to provide regular updates and seek feedback from members and clubs, which will continue in 2024.

BowlsLink use is continuing to grow with more members and clubs engaging with the system than ever before helping provide consistent and regular communications along with social media which allow to better disperse information as well as collect feedback. Bowls ACT encourage members to ensure their BowlsLink accounts are updated with correct email addresses and contact information, so they don't miss any important information.

September saw the second running of the Greenline Invitational Singles which provided the opportunity for Bowls ACT to live stream our first event. The live stream was well received with great viewership and engagement numbers. Thanks to all those that aided in commentary and the overall running of this event. Bowls ACT will continue to review and grow this concept to make it a marque event in the calendar.

November saw the return of the Defence Force test series which was well received and gave the opportunity for both current and up and coming representative players to play in a highly competitive test series and gain great exposure at the higher level of competition.

#### Looking Ahead

BACT is committed to further developing options to be able to live stream BACT and Club events with the aim to increase visibility and access to our sport. There will also be a strong focus on governance process and documentation to ensure all responsibilities are being fulfilled.

We look forward to continuing to develop programs and initiatives that will help Bowls ACT develop greater awareness of our sport while supporting the clubs and members that remain an integral part.

### **Executive Report**

Seeing out 2023 as my first full year in the role as Executive Officer I am pleased to have further developed my knowledge of the sport and the conventions in play across the capital region. I must give my thanks to the Bowls ACT Board and Committees for their guidance and support as well as to our members and volunteers who are the individual custodians of the success of our great game. Sadly, Bowls ACT was informed late in 2023 of the determination of Yowani Country Club to cease Bowls operations with the impending move to their new site, leaving the 109 members and much of Canberra's Northside community without a venue to play. I commend the spirit of the Yowani membership and thank all clubs who have welcomed the former Yowani members with open arms.

#### Strategic & Governance

Bowls ACT was measured against the ASC Sport Governance Principles for the first time in 2023, highlighting a number of areas which required improvement and will be ongoing targets as Bowls ACT strive to meet and exceed industry benchmarks with the adoption of a board directors code of conduct & board charter in October 2023. The report determined a number of other areas for improvement including;

- The implementation of a Finance, Audit & Risk Committee which will oversee governance & fiscal management.
- Improved reporting outcomes against governance standards being met within the Annual Report
- Updating policy around WWVP/WWCC
- Clear identification of potential conflicts of interest with BACT Staff & Directors with the development of a conflict of interest register.

The process also highlighted some of the good areas in which Bowls ACT is making steady progress from a strategic & governance perspective. Bowls ACT are working away at outcomes identified from the 2022-2025 Strategic Plan with the inception of more competition streams, with Mens Midweek Pennant (2022) and Graded Reserve Championships (2024) being developed to provide competitive opportunities to more. Further Bowls ACT have sought to improve member communications with Members Forums hosted across the year, which assist with improved digital uptake and upskilling the bowls workforce.

#### Financial

While Bowls ACT are pleased to return another surplus for FY2023 it must be noted that the ACT Government advised that the funding which has been made available to Category 3 sports (such as Bowls) will change in the next funding window (2024-2026) which challenges Bowls ACT's ability as an organisation to continue to offer a full-time professional administration and sustain the level of support currently offered.

Having had such a great Nationals in 2022, the bowlers in the ACT continued where they left off last year. The 2023 nationals was run and done with great success for our ACT region bowlers. This time we headed over to Western Australia. The junior representatives bounced back after having some major flight delays, and once again represented our small region with some high praise and regard from the other competitors. Our over 60's campaign also got off to a rocky start, but after everyone had their luggage sorted were able to have some great tussles with a tough competition.

Our open squads had one of our most successful years at the nationals, with both open men's and women's squads able to achieve some massive upsets and show the strength of bowls in the ACT. Australian Championships week saw our Womens Pairs combinations take home a bronze medal, which in its own right is a massive achievement at that level as well as Matt Barrie claim Gold with Vicki Parkinson (NSW) in the Open Para Pairs. I would like to congratulate every single bowler who competed over the 2 weeks and would hope to have some even better results moving into 2024.



The highlight for the ACT team was winning the boys triples match against TAS and only missing out on playing in the medal round on shot differential. William Lopez was astute in his role of Skip in this team and was ably supported by lead Jordan Sturgiss and Brayden Noonan called some great shots as second. Another great effort by the boys in the fours match saw them just fall short against the host state on Day 2.

It was also the first time in many years that we were able to provide 2 junior female bowlers with the opportunity to participate in the U18 Nationals. The girl's ability to gel with their teammates from WA was outstanding. The combined WA/ACT girls team played off for the bronze medal against South Australia. Lost 19-15 but gave them a real run for their money and picked up a 7 on one end. A great effort by the girls. Their progress as bowlers over the 2 days very satisfying to watch and was quite noticeable.

The ACT team overcame several transportation hurdles to make it to the Nationals and all bowlers were very competitive against quality bowlers, some of whom have been earmarked for higher honours, and with a bit of luck we may have progressed further in the competition. All associated with the team should be proud of their efforts.

In closing I would like to thank the parents/carers of our junior bowlers. The Yowani BC and Weston Creek BC for supporting junior bowls training throughout the year and Queanbeyan RSL Memorial BC for hosting the junior championships. Also congratulations to Yass BC for the positive development, and increase in numbers, of their junior bowlers throughout the year.

# Notes to the Financial Statements

# 1. Statement of significant accounting policies

The Directors' have prepared the financial statements on the basis that the Association is a nonreporting entity because there are no users dependent on a general-purpose financial report. The financial report is therefore a special purpose financial report that has been prepared to meet the requirements of the Associations Incorporation Act 1991.

#### 1.1 Basis of Preparation

The financial statements have been prepared from the records of the Association. They are on an accrual basis and are based on historical costs modified where applicable by the revaluation of selected non-current assets.

#### 1.2 Income Tax

No provision has been made for income tax as the Association as a not-for-profit sporting organisation is deemed exempt from income tax.

#### 1.3 Inventories on Hand

Inventories held for sale are measured at the lower of cost and net realisable value. The Directors have determined that inventories held will relate directly to the activities of the Association and will in the main consist of representative clothing and associated apparel together with Bowls Australia manuals.

#### 1.4 Property, Plant and Equipment

Plant and equipment are measured on a cost basis and are therefore carried at cost less accumulated depreciation.

The depreciable amount of all fixed assets is calculated on a straight-line basis over the asset's determined useful life commencing from the time the asset is held ready for use.

As shown in the table above Bowls ACT has received over the last three years 3 separate Funding Grants from the ACT Government. During the year total funds expended in relation to these grants was \$1,104 with a balance of funds remaining at 31 December 2023 of \$27,831.

The grant funds remaining have been identified as Income in Advance in the Financial Accounts and will be brought to account as income in the financial years when expenditures are incurred noting that the ACT Government has agreed to an extension of time for the activities associated with the grants to be completed.
